

ADMINISTRATION



Plan Check & Inspection Fee	\$235 per Equivalent Single-Family Residence (ESFR)
Annexation Fee	A one-time charge for property contiguous to District boundary \$290.00/acre, plus \$4,000.00 administration and legal deposit. May require more or less as needed to complete annexation process.
Annexation Deposit	When the District is the lead agency a deposit shall be made with the office of District Legal Counsel to cover legal and administrative costs of annexation. A further deposit shall be required for costs exceeding the deposit. Any unused portion of the deposit shall be returned to the depositor.

Commercial	A one-time charge based on fixture units & occupancy usage units: <ul style="list-style-type: none">• District \$5,443 per ESFR• City Varies for each City - Contact City Hall
Industrial	A one-time charge comprised of the following: <ul style="list-style-type: none">• District \$10.50/gallon/peak day \$2,608.10/pound B.O.D./peak day \$3,044.39/pound S.S./peak day• City Varies for each City - Contact City Hall
